PRODUCT INFORMATION:

DEMIZE is a unique broad spectrum natural herbicide made from Eugenol, an essential oil of clove, and molasses. It can be applied to control grass and weeds. Results are normally seen in less than a week but can take up to 10 to 14 days.

DIRECTIONS FOR USE:

Apply 1 to 2 quarts into 40 gallons of water per acre. It is recommended to bring the water pH range to a range of 5.2 to 5.6 prior to adding Demize. When applying, make sure to protect all desirable crop or plants from overspray as Demize will affect them. Do not apply to young trees or shrubs with green bark. For faster action apply with an approved surfactant. SHAKE WELL BEFORE USE. KEEP PROD-UCT AGITATED IN THE TANK.

DEMIZE is exempted from EPA registration under FIFRA 25 (b).
